## Self Declaration

This is to declare that Jesus and Mary College, Chanakyapuri, New Delhi managed by Provincial Society Delhi (Congregation of Jesus and Mary), a constituent college of University of Delhi is a Minority Educational Institution covered under Article 30 of the Constitution of India (Certificate by National Commission for Minority Educational Institutions, Government of India is attached herewith).

According to Article 15(5) of the Constitution of India, minority institutions covered under Article 30 shall be exempt from constitutional reservation of SC, ST and OBC Categories. The college follows the reservation policy of having 50 percent reservation for students belonging to a minority community, that is for the Christian students.

As per chapter VI section 32 of The Rights of Persons with Disabilities Act, 2016, All Government institutions of higher education receiving aid from Government shall not reserve less than 5 percent seats for persons with benchmark disabilities. The College adheres to the reservation policy in admissions for Persons with Disability (PWD) which are supernumerary seats as per DU norms. However, for the calculation of seats reserved for Divyangjans under criterion 2.1.2, the numbers have been excluded because of its supernumerary nature.

The list provided herewith is the final admission list indicating the student's intake under reserved category. However, it does not include the reserved category for M.A. students as the admissions for Post Graduate Programmes are done at the University level.
