Term and Termination

- 7.1 This Agreement shall be effective as of the Effective Date and shall remain in force for a period of one year unless terminated by either Party, under the provisions of Article 7.3 to 7.5 to this Agreement.
- 7.2 Termination of this Agreement shall not limit either Party from pursuing any other remedies available to it, including injunctive relief, nor shall termination relieve JMC of its obligation to pay all pre-approved charges that have accrued prior to such termination. Consent to extend the cure period shall not be unreasonably withheld, so long as the breaching Party has commenced such steps as are necessary to cure during the one (1) month notice period.
- 7.5 Either Party may terminate this Agreement immediately by written notice to the other Party upon the:
 - a) other Party becoming insolvent;
 - other Party's initiation of any proceeding under bankruptcy or insolvency law regarding its own bankruptcy, reorganization, or insolvency;
 - Initiation of any proceeding under bankruptcy or insolvency laws against the other party which is not dismissed within ninety (90) days;
 - appointment of a receiver or a similar officer for the other Party or for a substantial part of the other Party's property; or

On exit/ termination it shall be ensured that all pending dues are paid. In the event of closure of contract by JMC prior to agreed contractual period it shall be ensured that 33% of the fees that ay have accrued for the remaining period of contract are paid for premature closure.

8. Indemnification

8.1 Each Party shall indemnify and hold the other Party harmless from and against all direct losses, damages, liabilities, costs or expenses, which are caused or arise out of any act or omission or breach of such Party.

Limitation on Liability

9.1 Notwithstanding anything to the contrary contained elsewhere in the Agreement, neither Party shall be liable to the other Party for any indirect, 51P age

- 10.3 If any provision of this Agreement is found by any court of competent jurisdiction to be invalid or unenforceable, the invalidity of such provision shall not affect the other provisions of this Agreement, and all provisions not affected by such invalidity shall remain in full force and effect.
- 10.4 The waiver by either Party of a right arising as a result of a breach or default in any of the provisions of this Agreement by the other Party shall not be construed as a waiver of any rights arising as a result of succeeding breach of the same or other provisions; nor shall any delay or omission on the part of either Party to exercise or avail itself of any right, power or privilege that it has or may have hereunder operate as a waiver by the other Party.
