



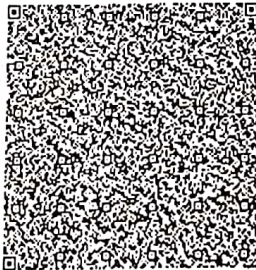

THIS AGREEMENT on the Terms of Engagement made at Delhi on this day of 10th day of October 2016.

between **JESUS AND MARY COLLEGE (JMC)**, having its registered institution at Chanakyapuri, New Delhi-110021, herein called "JMC" of the ONE PART and **Reformation Educare Pvt Ltd. (REPL)** located in house no 3, Ground Floor, Colony, Satya Niketan, New Delhi-110021., India, herein after called REPL" of the OTHER PART.

NOW THIS AGREEMENT WITNESSES AS FOLLOWS:

1. This agreement is between JMC and REPL, regarding Civil-Service Coaching & resource support for the same.
2. The objective of these coaching classes is to prepare the students belonging to reserved and minority communities to get gainful employment in Group A, B or C central services and state services or equivalent positions in the private sector.
3. JMC conducted a qualifying test for screening candidates on 24th August, 2016 with the resource support of REPL at JMC.
4. Number of students in one batch will not exceed 50 students as per UGC guidelines XII Plan.
5. The orientation with the students was conducted in August 2016 at JMC to motivate them for Civil Services.
6. The classes conducted would prepare the students for both Pre-examination & Mains Examination in History, Geography, Polity, General Science, Maths, Environmental Science, Current Affairs etc.
7. The classes will be conducted in JMC between 3:45 p.m. to 5:45 p.m. Monday — Friday; and, between 9:00 a.m. to 1:00 p.m. on Saturdays, as per the schedule of JMC students. JMC and REPL, with a mutual understanding, can make changes if required.

8. JMC will be paying Rs. 500/- per lecture (60 minute) and additional TA of Rs. 500 per day.
9. The payment will be drawn through cheque to the teachers involved as per their lecture hours on calculations by JMC. The payment shall be done at regular intervals.
10. REPL will provide every possible resource support to JMC for successful completion of the programme.
11. This agreement (MOU) is for one academic year July 2016 — May 2017 and is subject to renewal on annual basis.
12. The terms of renewal and agreement towards the same for the year July 2017-May 2018 would be finalized by July 2017. and is subject to the unilateral decision of the College.
13. The college reserves the right to terminate the contract with immediate effect in case of any serious offence, by REPL.
14. Any disputes arising between the parties shall be referred to the sole arbitrator appointed by the college and the decision/award of such arbitrator shall be binding upon the parties hereto.
