 - Support for Student Information Management (Certificate, Reports)
 - Support for Fees Module (Complete Fees Module)
 - Support for Payroll Module (Complete Payroll Module)
- 2. That the above software modules would be running on Windows operating system MS Windows 98/2000/XP/win2007, and SMPL hereby explicitly undertaken to keep the said software in working order on any updated version of above mentioned operating system in the future i.e. it is the responsibility of the software developers to take care of future changes in operating systems and hardware environment changes. So that the software is kept in working order for a lifetime.
- 3. That the agreed contract price
 Rs. 90,000/- (Ninety Thousand only) Yearly + Service Tax (if applicable) for online
 support and max 15 ticket.
- 4. Payment Terms

50,000/- + S.T in advance at the time agreement, 40,000/- + S.T after six month of agreement date.

5. Subject to the requirement of JMC the S/W supplier SMPL provides online support, visit when required.

- 6. SMPL also hereby undertakes to identify JMC of any losses suffered due to piracy copyright / intellectual property right issue, inspection of the same by any agency whether government or private and levy of any fine, penalty, duty by whatever name called; due to the software not adhering to any laws, policies or procedures by whatever name called; which SMPL as a commercial software solutions provider should have taken care of, or otherwise, or as the case may be. A separate indemnity bond is also to be issued by SMPL for the purpose.
- 7. SMPL is duly registered with the service tax department as a software services provider as it claims and that SMPL takes on to be scrupulous in filling its returns and tax reposition collected during the course of it business. Similarly SMPL undertakes to be equipped with technical staff competent to handle this kind of assignment and in case latter it is found that the facts has mentioned above are otherwise and that there were gross misrepresentation for the sole purpose of acquisition of the contract. JMC would be entitled to a full refund and also damages for misrepresentation and fraud in a court of law. The above clauses should be taken in its true spirits as a precautionary step.

8. SMPL hereby undertakes to customize/Support the software modules as per the needs of

the college.

- 9. Some work/task are pending as per the previous contract of JMC with SMPL. JMC has agreed to sign an Annual Maintenance contract with SMPL for one year whereby SMPL is required to complete all the previous pending Jobs in AMC period falling which last installment of AMC will not be cleared.
- 10. SMPL and JMC mutually agreed that JMC may buy the account package from any third party, cost will be deducted from AMC Fees of SMPL.
- 11. All dispute with regards to above and this contract generally would be a matter of jurisdiction of the courts of Delhi state only.
- 12. The duration of this agreement is one year.

13. The Principal has the rights and the authority to cancel the agreement in case of any infringement or in case of indiscipline.
