We are sending you information in response to your email dated 19th August 2019. Please find below the necessary information from Jesus and Mary College. The response is delineated as per your specific questions.

- a) Whether you have made arrangement in your College to help a student, if he or she is experiencing any stress or related issue?
- A. The college has been hiring the services of trained part-time counselors since 2015. The counselors are available for consultation at least three times a week. At present, the college has three counselors, Ms Prachi Akhavi, Ms Asmita Sharma and Ms Jyothi John. All three are trained psychotherapists.
- b) Whether you have counseling service for students in the College?
- A. As stated above, the college has been hiring the services of part-time counselors.
- c) Whether you have taken steps to sensitize your faculty members and administrative officials to understand and address the problems of students who experience stress and related issue?
  - A. The counselors have been organizing special pograms for Mental Health Week and other workshops/events that help address issues beyond individual counseling. This apart, the counselors have been also organizing department-wise interactions with the teachers so as to flag some prominent issues that students are sharing during counseling. These interactions have helped some faculty members understand the importance of identifying signs of stress in students.

The College follows the practice of Mentor Ward System where the students of each department are divided into small groups which are mentored by the teachers. The teachers sign up for two periods in their time table during which they are accessible to the students for counselling.

The college Women's Study Centre (WSC), one of the compulsory societies of the college, shall be organizing workshops around tackling problems related to stereotypical body images, eating disorders, etc. There shall also be an attempt by the WSC to involve students in a project on online bullying.


These are some of the initiatives planned.

The election to the student members' posts in the college's ICC is going to be conducted on 14th March 2018 (coming Wednesday) in the Activity period, i.e. between 12.30 pm and 1:45 pm in Room 305.

#### Kindly make note of the following instructions and code of conduct:

1. There are 3 posts of student members for which elections are being held.

2. The elections will be for <u>one post in the case of 2nd year candidates</u>, and for <u>two posts in the case of 1st year candidates</u>. [So one candidate shall be elected from among the 8 second year candidates, while 2 candidates shall be elected from among the 13 first year candidates.]




